As a student-athlete host, you represent the University of Louisiana at Monroe and your sport program, and are expected to conduct yourself with the utmost integrity. You have a responsibility to understand and abide by NCAA, Sunbelt Conference and institutional regulations. **Please read carefully the following rules:**

- ☛ Only one student-athlete per day from our school can serve as an official host. Freshman must be certified as a qualifier, in order to serve as a student host. Other students may assist with hosting the prospect but shall pay for their own entertainment and meals.
- ☛ A maximum of \$40 for each day of the visit may be provided to cover all actual costs of entertaining yourself, the prospect (and the prospect's parents, legal guardians or spouse), excluding the cost of meals and admission to campus athletic events. These funds may not be used for the purchase of souvenirs such as T-shirts or other institutional mementos.
- ☛ No cash may be given to the visiting prospect or anyone else.
- ☛ You may not use vehicles provided or arranged for by any coach, institution staff member or booster of the university. **Never** allow the recruit to use or drive your car.
- ☛ You may not transport the prospect or anyone accompanying the prospect more than 30 miles from the campus.
- ☛ You should not allow recruiting conversations to occur on or off campus between the prospect and a booster of the athletic program. **(If an unplanned meeting occurs, only an exchange of greetings is permissible.)**
- ☛ A visiting prospect may engage in recreational or workout activities, provided such activities are not organized or observed by members of the athletics department coaching staff and are not designed to test the athletics abilities of the prospect. Use of the institution's facilities for such activities is permitted, provided athletics department staff members or representatives of its athletics interests are not involved in the conduct, promotion or administration of the activity (other than activities incidental to supervising the use of the facilities).
- ☛ You may receive a complimentary admission (no hard tickets) when accompanying a prospect to a campus athletic event.
- ☛ You may **NOT** provide, assist, or take the prospect to any of the following:
 - Attend any adult entertainment venues
 - Provide excessively expensive meals and transportation
 - Partake in giving tobacco products or alcohol to under-aged recruits
 - Provision of elaborate transportation, such as limousines
 - Use escort services, exotic dancers, or other similar services
 - Participate in unethical or illegal activity, such as provision/use of drugs, or participation in gambling activities
 - Activities at any location that may cause a perception of impropriety
